# 1. Objective:

- 1.1. The objective of the game is for a Totem Herd to capture a Wahi Pili's totem and return it safely to their home Wahi Pili, all while adhering to the game's rules and constraints.

# 2. Setup:

- 2.1. **Lodge Participation:** Lodges will determine their own participation by a vote of the floor and determine which of their committees will manage their participation.
- 2.2. **Distance Limit:** Wahi Pili participating in the game may not capture the totem of a Wahi Pili more than two hundred (200) miles away from each other, unless mutually agreed upon in advance by both Wahi Pili governing committees in whatever manner deemed fit and mutually agreed upon.
- 2.3. **Initial Lodge Invitations:** Lodges within two hundred (200) miles of the initial Hale Hookipa (Host Lodge) are invited to participate. The Hale Hookipa for the inaugural season will be Pascagoula Lodge 1120. At the conclusion of the 2024-2025 fraternal year, each participating Wahi Pili will send a representative to the Totem Awards Luau ceremony at the Hale Hookipa where the following year's Hale Hookipa will be selected from applicant Wahi Pili.
- 2.4. **Applications for Participation by Lodges:** Lodges may apply at any time to participate as a Wahi Pili in the competition by applying on [PascagoulaElks.org/totem](https://PascagoulaElks.org/totem).
  - 2.4.1. Applications will be forwarded to all participating Wahi Pili for consideration of inclusion at the annual Totem Awards Luau. A vote is by the usual voting sign of an Elk with the majority votes being cast to the Wahi Pili to be allowed entry into the competition.
  - 2.4.2. However, with at least thirty (30) days' notice to current participating Wahi Pili, the Hale Hookipa can call a special meeting to consider applications on an emergency basis.
    - 2.4.2.1. A quorum of two-thirds (2/3) of participating Wahi Pili must be present for an emergency application vote.
    - 2.4.2.2. The voting process will be as described in rule 2.4.1.
    - 2.4.2.3. Wahi Pili being admitted during an ongoing competition year are not assessed any penalty nor are they awarded any compensation points.
    - 2.4.2.4. Wahi Pili newly admitted for participation begin competition on April 1 of each year. (This rule will take effect on April 1, 2024)
  - 2.4.3. Participating Wahi Pili will be provided an official Totem Herd Trumpet (if a new Wahi Pili) and its maximum number of retention rules promissory cards prior to April 1 of each competition year. (This rule will take effect on April 1, 2024)
- 2.5. **Awarding Of Hale Hookipa:** The Totem Master, or a Past Totem Master of the Hale Hookipa shall preside during the Totem Awards Luau at which the nomination and award of the Hale Hookipa for the following competition year shall be made.



- 2.5.1. Nomination shall be made by any Totem Master or their alternate and seconded by another Totem Master or their alternate of another participating Wahi Pili for the purpose of nomination to Hale Hookipa.
- 2.5.2. The election shall be by written or printed ballot, uniform in size and color, which shall be provided by the Hale Hookipa.
- 2.5.3. The casting of each ballot shall be secret.
- 2.5.4. The nominee receiving the majority of the votes cast shall be declared elected. Should no nominee receive a majority of the votes, additional balloting shall be held eliminating from those ballots the nominee receiving the fewest votes on each ballot until a nominee shall receive the majority of the votes cast.
- 2.5.5. In case there shall be but one nominee for any office, the presiding Totem Master shall cast the vote of the Lodge for the nominee.
- 2.5.6. Hale Hookipa shall regulate the game and mediate rules disagreements between Wahi Pili as well as plan and host the Totem Awards Luau. Its term shall be April 1 through March 31 of the Fraternal Year.
- 2.6. **Totem Design:** Each Wahi Pili must have a distinctive totem or flag that represents their Wahi Pili.
  - 2.6.1. The totem should be easily distinguishable from a distance.
  - 2.6.2. Wahi Pili shall acquire their own totem and it shall remain the property of that Wahi Pili.
  - 2.6.3. For the sake of respect for the animal for which our Order is so named, no Elk or representative of such shall be utilized as a totem, nor shall any totem bear the Elks USA logo or Clock Face of the Benevolent and Protective Order of Elks.
  - 2.6.4. Totems shall not be larger than eighteen inches in height, eighteen inches in width, nor eighteen inches deep.
  - 2.6.5. Totems may be named but should be in good taste.
    - 2.6.5.1. Totem names shall not contain the word Elk, Elks, BPOE or any copyrighted or trademarked image or name of the Benevolent and Protective order of Elks.
  - 2.6.6. Totems shall not weigh more than fifteen (15) pounds.

### 3. Totem Herd Composition:

- 3.1. **Totem Herd:** Totem Herds consist of a minimum of five (5) members of the competing Wahi Pili shall be referred to as a Totem Herd. Totem Herds need not consist of the same members for separate competing actions.
- 3.2. **Herd Master:** The member of the Totem Herd who knows or should know the rules of the game - but does not necessarily have to. It could be good to know them, because not knowing the rules can cost you points.
- 3.3. **Herd Totem Bearer:** The member of the Totem Herd who will care and control the totem, ensuring its safety until its return to the Totem Herd's Wahi Pili.
- 3.4. **Herd Toastmaster:** The member of the Totem Herd who will state the capture or rescue phrase, thus officially securing the action.



- 3.5. **Herd Horn Blower:** The member of the Totem Herd who will sound the official horn during the capture/rescue procedure.
- 3.6. **Herd Herald:** The member of the Totem Herd who shall read the official declaration of the Totem Herd's intent as prepared for and signed by their Wahi Pili Totem Master.
- 3.7. **Member Defined:** A member is defined as a Member of the Benevolent and Protective Order of Elks, who must also be able to present a membership card from the Wahi Pili from which the competing Wahi Pili has been dispatched showing membership in good standing.

## 4. Wahi Pili Composition:

- 4.1. **Wahi Pili Defined:** The lodge housing a captured totem or housing its own totem.
- 4.2. **Totem Master:** Designee named/elected by the participating Wahi Pili's discretion that signs proclamations of intent to capture/rescue totems which must be presented by a Totem Herd to a Wahi Pili during its attempt to capture/rescue a totem. There may be only one (1) named Totem Master per participating Wahi Pili.
- 4.3. **Totem Knight:** Designee(s) named/elected by the participating Wahi Pili's discretion that may, in lieu of the Totem Master, authorize the offer of promissory cards as it relates to the retention rules. There may be up to five (5) named Totem Knights per participating Wahi Pili.
- 4.4. **Totem Scorer:** Designee named/elected by the participating Wahi Pili who will file the official scoring for a successful capture/rescue of a totem from a Wahi Pili. There may be only one (1) named Totem Scorer per participating Wahi Pili.
- 4.5. **Totem Keeper:** Designee named/elected by the participating Wahi Pili who oversees handing over a captured totem to the Totem Herd and maintaining all other totems in a place of prominence while displayed. There may be as many Totem Keepers as desired by a Wahi Pili, and the duties may be delegated as required to prevent delay in the surrender of a totem during its capture. It is also the responsibility of the Totem Keeper to verify the membership eligibility of the Totem Herd.

## 5. Game Rules:

- 5.1. **Totem Placement Rules:** The totem can only be captured when it is displayed in the Wahi Pili's hall, lounge, social quarters, or a predetermined location within the Wahi Pili or the grounds of the Wahi Pili.
  - 5.1.1. Totems may not be hidden or placed in a location where it is not easily accessible to the Totem Keeper or their alternate for the purposes of surrendering to the capturing/rescuing Totem Herd.
  - 5.1.2. Totems cannot be taken from a member's home or any other personal location.
- 5.2. **Capture/Rescue of a Totem:**
  - 5.2.1. **Totem Capture:** To capture a Wahi Pili's totem, a Totem Herd must physically travel to a Wahi Pili's designated location, conduct the capturing procedure, and bring the totem back to the Totem Herd's home Wahi Pili.



- 5.2.2. **When Totem Herds May Act:** Totem Herds must visit the social quarters/lounge of or participate in an event or fundraiser that the Wahi Pili is conducting when attempting to rescue their own totem or capture the Wahi Pili's totem.
- 5.3. **Prohibitions:** Totem Herds may only attempt capture of the totem of the Wahi Pili being visited, and not the totem of any other Wahi Pili.
- 5.3.1. Players may only rescue their own totem or capture the Wahi Pili's totem but cannot do both on the same day of participation. However, this does not prevent a Totem Herd from capturing the totems from other Wahi Pili on the same day they have rescued their own from another Wahi Pili.
- 5.4. **Rescue:** Wahi Pili must rescue their own totem from the possession of the Wahi Pili first before they are eligible to return to capture that Wahi Pili's totem.
- 5.5. **Capture prior to Rescue:** A Totem Herd may capture totems from a Wahi Pili even if its own totem has been captured and not yet been rescued from another Wahi Pili's possession.
- 5.6. How Totem Is Captured/Rescued:
- 5.6.1. Herd Horn Blower sounds two blasts on the official Totem Herd Trumpet.
- 5.6.2. Herd Master announces, "The [NAME OF WAHI PILI and NUMBER] is officially capturing/rescuing your/our totem in the name of fellowship."
- 5.6.3. The Herd Herald shall read the capture/rescue proclamation issued by their Wahi Pili's Totem Master.
- 5.6.4. The defending Wahi Pili may invoke a retention rule if desired.
- 5.6.5. The Totem herd may make a counteroffer on a retention rule if desired.
- 5.6.6. The Herd Totem Bearer receives the totem if successfully captured/rescued.
- 5.6.7. The Herd Toastmaster makes a toast based on success/failure of capture/rescue.
- 5.6.8. The Herd Horn Blower sounds two blasts on the official Totem Herd Trumpet.
- 5.7. **Totem Retention:**
- 5.7.1. **Mike Nobles Rule:** \$600 may be offered by promissory presentation card to the Wahi Pili attempting capture which entitles the Wahi Pili attempting capture to \$300 to the charity of the Wahi Pili's choice and \$300 to the State Major Project for the State Association of the Totem Herd and entitles the Wahi Pili offering the promissory immunity from all attempts from the capture from all attempts from the capture of their totem for a period of six (6) months - including into a new season of the game. This may only be presented once per Wahi Pili in a calendar year and must not be presented within thirty (30) days of the presentation of promissory cards of the Charlie Duffie or Mike Gordon Rules.
- 5.7.2. **Charlie Duffie Rule:** \$300 may be offered by promissory presentation card to the Wahi Pili attempting capture which entitles the Wahi Pili attempting capture to \$150 to the charity of the Wahi Pili's choice and \$150 to the State Major Project for the State Association of the Totem Herd and entitles the Wahi Pili offering the promissory immunity from all attempts from the capture and entitles the Wahi Pili offering the promissory immunity from all attempts from the capture of their totem for a period of ninety (90) days - including into a new season of the game. This may only be presented twice per Wahi Pili within a calendar year and there must be a thirty (30) day cool off period between the presentation of this rule's promissory card and the presentation of promissory cards of the Mike Gordon or Mike Nobles Rule.



- 5.7.3. **Mike Gordon Rule:** \$150 may be offered by promissory presentation card to the Wahi Pili attempting capture which entitles the Wahi Pili attempting capture to \$100 to the charity of the Totem Herd's Wahi Pili and \$50 to the State Major Project for the State Association of the Totem Herd and entitles the Wahi Pili offering the promissory immunity from all attempts from the capture of their totem for a period of thirty (30) days - including into a new season of the game. This may only be presented twice per Wahi Pili within a calendar year and there must be a thirty (30) day cool off period between the presentation of this rule's promissory card and the presentation of promissory cards of the Mike Nobles or the Charlie Duffie Rule.
- 5.7.4. **John F. Malley Rule:** \$50 may be offered immediately to be donated to the Elks National Foundation on behalf of the Totem Herd's Wahi Pili. However, if a Totem Herd consists of more than five (5) members, for each additional member of that Totem Herd an additional \$5 immediate offer shall be assessed. This entitles the offering Wahi Pili immunity from all attempts from the capture of their totem for a period of seven (7) days - including into a new season of the game. For example, the Totem Herd consists of nine (9) members attempting capture of a totem, the required offering would be \$70. There is no cool down for the use of this retention rule and it may be invoked as often as desired by an offering Wahi Pili.
- 5.7.5. **Charles Vivian Rule:** The Wahi Pili having possession of the captured totem of the arriving Totem Herd may prevent its rescue. \$100 may be offered immediately to be donated to the Elks National Foundation on behalf of the Totem Herd's Wahi Pili. However, if a Totem Herd attempting rescue consists of more than five (5) members, for each additional member of that Totem Herd an additional \$10 immediate offer shall be assessed. For example, the Totem Herd consists of nine (9) members attempting capture of a totem, the required offering would be \$140. This entitles the offering Wahi Pili immunity from all attempts from the rescue of the Totem Herd's totem for a period of seven (7) days - including into a new season of the game. There is no cool down for the use of this retention rule and it may be invoked as often as desired by an offering Wahi Pili.
- 5.8. **Safety:** Safety should be a priority. Any form of physical harm or force to capture, rescue or defend a totem is prohibited. The game should be fun and safe for all participants.
- 5.9. **No Resisting:** Wahi Pili members should not physically resist or obstruct the authorized capture or unauthorized theft of their totem.
- 5.10. **Event Participation:** Participation in events hosted by the Wahi Pili shall include taking part in games, contests, or other charitable activities or events. Examples of activities include raffles, meals, organized events, ticketed events, free events, assisting with Hoop Shoot, Drug Awareness Programs, etc.

## 6. Scoring and Records:

- 6.1. Records of successful totem captures by each Wahi Pili must be made and the use of these records shall determine an overall winner.



- 6.2. **Fair Play and Sportsmanship:** Emphasize fair play, sportsmanship, and camaraderie throughout the game. Encourage participants to enjoy the experience and build positive relationships between Wahi Pili.
- 6.3. **Scoring System:**
- 6.3.1. **Totem Capture (Primary Scoring):** The primary objective of the game is to capture the Wahi Pili's totem and return it to the Totem Herd's Wahi Pili. A Totem Herd successfully capturing the Wahi Pili's totem shall be awarded ten (10) points.
- 6.3.2. **Totem Recovery (Secondary Scoring):** A Totem Herd successfully recovering its own totem from the Wahi Pili in possession of the totem shall be awarded five (5) points.
- 6.4. **Additional Points:**
- 6.4.1. **Here Today, Gone Tomorrow Bonus:** If a Totem Herd successfully rescues its totem within twenty-four (24) hours of its capture by Wahi Pili, ten (10) extra points shall be awarded.
- 6.4.2. **A Week's Vacation Bonus:** If a Totem Herd successfully rescues its totem within one (1) week of its capture by a Wahi Pili, five (5) extra points shall be awarded.
- 6.4.3. **Costume Participation Bonus:** Totem Herds and Wahi Pili are encouraged to be costumed during the capture/rescue/defense actions.
- 6.4.3.1. Totem Herds capturing or rescuing a totem while all members of the Totem Herd are costumed that post a photo of the capture/rescue on Find Em, Totem and Run! Facebook page within twenty-four (24) hours of the capture/rescue shall be awarded ten (10) extra points.
- 6.4.3.2. However, an entire Totem Herd costumed in grass skirts and reed headdresses shall be awarded twenty-five (25) extra points in accordance with rule 6.4.3.1.
- 6.4.3.3. Wahi Pili defending the capture/rescue of a totem who have at least five (5) members attired in costume that post of photo of the defense of the capture/rescue on the Find Em, Totem and Run! Facebook page shall be awarded twenty (20) points.
- 6.4.3.4. However, a Wahi Pili defending the capture/rescue of a totem who have at least five (5) members attired in grass skirts and reed headdresses shall be awarded twenty-five (25) extra points in accordance with rule 6.4.3.3.
- 6.5. **Reporting Score:** PascagoulaElks.org/totem form shall be filled out within 48 hours of the capture/rescue of a totem by a Totem Herd for the purpose of officially reporting their score.
- 6.6. **Time Frame of Game:** April 1 through March 1 – Awarded 2<sup>nd</sup> Saturday of March.
- 6.6.1. The competition year shall commence at 12:00 AM on April 1 of each fraternal year and end at 12:00 AM on March 1 of the fraternal year.
- 6.7. **Game Winner:** At the end of the game or tournament, the Hale Hookipa shall tally up the points earned by each Wahi Pili to determine the overall winner. The Wahi Pili with the most points wins. In the event of a tie in points, the Wahi Pili with the greatest number of times its totem has been rescued shall be the winner. If a tie persists, both Wahi Pili shall be declared co-champions.



- 6.8. **Prizes:** The Pu'upu'u 'Ino Totem shall be awarded to the winning Wahi Pili, and a name plate plaque attached indicating the year of competition and the winning Wahi Pili. At no time shall the Pu'upu'u 'Ino Totem be captured by or surrendered to a Totem Herd. The Pu'upu'u 'Ino Totem shall be surrendered only to the Hale Hookipa at the annual Awards Luau for presentation to the winning Wahi Pili.

## 7. Totem Awards Luau and Participation Costs:

- 7.1. **Annual Participation Cost:** Participating Wahi Pili shall be assessed a \$100 per year fee remittable to the Hale Hookipa by the 15<sup>th</sup> of April of the competition year.
- 7.1.1. The Hale Hookipa shall utilize fees to offset the costs for the annual award plate for the Supreme Totem, Totem Herd Trumpets ordered and distributed in accordance with rule 2.4.2, and to offset costs of organizing and hosting the Totem Awards Luau.
- 7.1.2. The Hale Hookipa shall make accounting to the participating Wahi Pili of all funds associated with collected fees within 30 days of the start of the next competition year.
- 7.1.3. All excess funds shall be donated to the State Major Project of the State Association of the Hale Hookipa within 30 days of the final accounting of collected funds.
- 7.1.4. Participating Wahi Pili are entitled to four entries to the Awards Luau at no cost to the Hale Hookipa by way of a participating Wahi Pili's participation fee.
- 7.1.5. The Hale Hookipa, may at its discretion, sell tickets to the Awards Luau to offset costs of additional attendees – however, funds raised by the sale of tickets are considered included in rules 7.1.2 and 7.1.3 for accounting and for excess distribution.
- 7.1.6. All participating Wahi Pili are encouraged to decorate their own tables and hold raffles or fundraisers for their Wahi Pili at the Awards Luau. The Hale Hookipa may also participate in this fundraising as this shall not be considered as funds raised in rule 7.1.5.

## 8. Additional Rules:

- 8.1. **Lodge Accessibility:** Wahi Pili must provide ample opportunity beyond regularly scheduled meetings for Totem Teams to recover their totems or to capture the Wahi Pili's totems.
- 8.2. Lodges should not participate that have limited accessibility to the lodge, especially on Fridays or weekends.
- 8.3. Participating Wahi Pili shall maintain updated hours, contact, and lodge officer information on Elks.org.
- 8.4. Totems may not be captured from the Hale Hookipa hosting the Awards Luau on the day the program is conducted.





## Promissory Cards:

- 8.5. The Hale Hookipa shall issue Promissory Cards to each participating Wahi Pili for the competition year.
- 8.6. There shall be issued per participating Wahi Pili one (1) Mike Nobles Rule card, two (2) Charlie Duffie Rule cards, and two (2) Mike Gordon Rule cards.
- 8.7. The Hale Hookipa shall emboss the Promissory Cards with a raised seal of their own Wahi Pili or the Find Em, Totem and Run! Official seal prior to issue.
- 8.8. A promissory card that is not embossed as described in rule 8.7 shall not be valid.
- 8.9. Wahi Pili may present the cards to a Totem Herd attempting capture of the Wahi Pili's totem only under the following conditions:
  - 8.9.1. The Wahi Pili may not present a promissory card to a Totem Herd unless it has been signed by the Wahi Pili's Totem Master affirming the Wahi Pili can immediately satisfy the promissory note.
  - 8.9.2. Only a Totem Master or a Totem Knight may authorize the presentation of the promissory note.
  - 8.9.3. The Wahi Pili's governing committee must satisfy the financial promise of the card within ten (10) business days of the submission of the promissory note for satisfaction and provide proof of donation(s) to the submitting Totem Herd's Wahi Pili and to the Hale Hookipa's governing committee.

## Rules Violations:

- 8.10. Wahi Pili violating rules of the game are subject to point deductions, monetary fines, and/or suspension from the game.
  - 8.10.1. An injured Wahi Pili shall make a complaint regarding the violation including the name of the Wahi Pili violating a rule, the rule violated, the date and time of the violation, the participants of the violation (if known), and any information relevant to the violation.
  - 8.10.2. Complaints shall be made to the Hale Hookipa via complaint submission form located at [PascagoulaElks.org/totem](http://PascagoulaElks.org/totem).
  - 8.10.3. Taking of a totem by an authorized Totem Herd without the knowledge of the Wahi Pili possessing the totem will result in a \$500 assessment to the violating Totem Herd's Wahi Pili if found in violation. Said assessment shall be made to Elks National Foundation in the name of the Wahi Pili who possessed the improperly obtained totem.
  - 8.10.4. The violating Totem Herd's Wahi Pili shall be suspended from participation in the competition until said assessment is made.
  - 8.10.5. Any second violation of this rule by the offending Wahi Pili shall result in a \$1000 assessment and suspension to the violating Totem Herd's Wahi Pili in the same manner as described above.
  - 8.10.6. A third violation by a Totem Herd's Wahi Pili shall result in suspension of the violating Wahi Pili until a hearing may be held at the Awards Luau where the



representatives of the participating Wahi Pili may hear evidence as to why the violating Wahi Pili should not be removed from further participation in the competition, which may decide on suspension up to three (3) years of suspension.

- 8.10.6.1. A second hearing on the same violating Wahi Pili will result in permanent banishment from the competition if found in violation.
- 8.11. Wahi Pili must report a totem taken without their knowledge by an authorized Totem Herd to the Hale Hookipa for determination of violation, who shall then determine the assessment as described above.
- 8.12. A totem taken by force by an authorized Totem Herd will result in the immediate suspension of that Wahi Pili from participation in the competition pending a hearing at the Awards Luau where the representatives of the participating Wahi Pili may hear evidence as to why the violating Wahi Pili should not be permanently removed from competition.
- 8.13. A Wahi Pili refusing the surrender of a totem to an authorized Totem Herd who has performed the proper ritual and who has not invoked a retention rule shall result in a \$300 assessment to the violating Wahi Pili. Said assessment shall be made to the Elks National Foundation in the name of the Totem Herd's Wahi Pili.
- 8.14. A Wahi Pili refusing to satisfy the financial promise of the card within ten (10) business days of the submission of the promissory note for satisfaction and provide proof of donation(s) to the submitting Totem Herd's Wahi Pili and to the Hale Hookipa's governing committee, shall be suspended from participation in the competition until a hearing may be held at the Awards Luau where the representatives of the participating Wahi Pili may hear evidence as to why the violating Wahi Pili should not be removed from further participation in the competition, which may decide on suspension up to three (3) years of suspension and or an assessment of not less than \$1000 per violation to the violating Wahi Pili to be made to the Elks National Foundation in the name of the injured Wahi Pili(s).

## Does This Break the Rules?

Q: A Totem Herd showed up with 11 people. Our Totem Keeper did not verify membership and there were only 3 actual members. We surrendered our totem. Is that cheating?

A: No. This is part of the fun of the game. Go and rescue your totem and laugh about it.

Q: A Totem Horn Blower didn't really make a true blast on the horn. So that means they didn't follow the ritual, right?

A: Some people are not musically inclined and if all they did was make ANY sound, then that constitutes a blast on the horn. You can laugh at their poor attempt to make noise.

Q: I called a Wahi Pili ahead of time to make sure their totem was there before I drove 200 miles to capture their totem and it was not there. They lied to me.



A: The point of this game is to have social interaction between Wahi Pili. They pulled the wool over your eyes. Do the same to them, and next time check the totem page at [PascagoulaElks.com/totem](http://PascagoulaElks.com/totem) to see if the Totem Chart has been updated showing if they are in possession of their totem or not.

### PROCLAMATION OF CAPTURE
